To the registered voters of Forsan Independent School District, Forsan, Texas:

A Tax Ratification Election ("VATRE") will be held on November 8, 2022, during the hours prescribed by law (7:00 a.m. to 7:00 p.m.), within the Forsan Independent School District pursuant to Sections 26.05 and 26.08 of the Texas Tax Code.

At the Election, the following proposition shall be submitted to the qualified voters of the District in accordance with law:

"Ratifying the ad valorem tax rate of \$1.1646 in Forsan ISD for the current year, a rate that will result in an increase of 16.03 percent in maintenance and operations tax revenue for the district for the current year as compared to the preceding year, which is an additional \$1,081,509.00."
