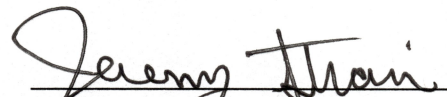

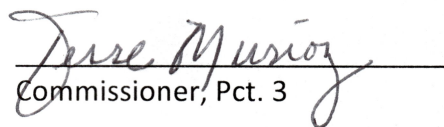
The County Treasurer's June 2025, Cash Position Report states the amount of cash and other assets in the custody of the County Treasurer.
